In consideration of the transfer of the animal described above, the adopter agrees to:

- ◆ Treat this pet humanely at all times as described by the Rights of the Rescued.
- ◆ Obtain medical care and continue vaccination schedule as recommended by your vet.
- ◆ NEVER tether (tie up) the animal outside or allow pet to run loose outside your premises.
- ◆ NEVER leave pet unattended outside. Coyotes will attack and Birds can carry them away.
- ◆ Allow the animal reasonable access outside each day and to be inside the home every night.

**Please Initial each:**

\_\_\_1) Keep a current animal license and ID tag with your phone number on the pet at all times and provide any and all needed medical care.

\_\_\_\_2) If the animal can no longer be kept or cared for by you one option is to contact an FPAR staff member for training referral or relinquishment. A Relinquishment fee of  $\frac{1}{2}$  adoption will apply. Donation adoption fees are not refundable.

\_\_\_\_3) Rescued animals may have an undetected or pre-existing medical condition, or may have been exposed to parasites or communicable diseases. FPAR has diligently attempted to professionally discover these conditions and will disclose all known conditions. The adopter assumes the risk of these possibilities for this point forward.

\_\_\_\_4) To release, hold harmless and forever discharge Forgotten Paws Animal Rescue, or any of the Directors or volunteers from any and all claims arising from the adoption of this animal(s). All information with respect to the animal's health and behavior that is known has been represented and disclosed by Forgotten Paws Animal Rescue, Directors or any volunteer affiliates in good faith. This agreement is binding on the adopter and all members of the adopter's household.
